**OFFICE ORDER NO. 1343 /2010**

The Screening Committee in pursuance and implementation of the Assured Career Progression Scheme for the Central Government employees as notified vide DP&T's O.M. No. 35034/1/97-Estt(D) dated 09-08-1999 has approved financial upgradation of Smt. Sheeba Jayaraj, Jr. Hindi Translator, presently in the Pay Scale of Rs. 5500-175-9000/- to the Pay Scale of Rs.6500-200-10,500/- i.e. pay scale of Sr. Hindi Translator w.e.f. 25.5.2007 on being granted 1st financial upgradation under ACP Scheme on completion of 12 years service.

Grant of higher pay-scale under the A.C.P. Scheme shall be conditional to the fact that an employee, while accepting the said benefit, shall be deemed to have given his/her unqualified acceptance for regular promotion on occurrence of vacancy subsequently. In case he/she refuses to accept the higher post of regular promotion subsequently, he/she shall be subject to normal debarment of regular promotion as prescribed in the general instructions in this regard.

The proposed A.C.P. Scheme contemplates merely placement on personal basis in the higher pay-scale/grant of financial benefits only and shall not amount to actual/functional promotion of the employees concerned.

Before implementing the financial benefits under A.C.P. Scheme to the Jr. Hindi Translator concerned branch should satisfy with reference to the service book of the official that they have completed 12/24 years service on or before the date mentioned in this order. In case of any anomaly, matter may be referred to Head Office.

On upgradation under the A.C.P. Scheme, pay of an employee shall be fixed under the provisions of FR 22(I) a(1) subject to a minimum financial benefit of Rs. 100/- as per rules. The financial benefit allowed under the A.C.P. Scheme shall be final and no pay-fixation benefit shall accrue at the time of regular promotion i.e. posting against a functional post in the higher grade.

The above official are required to exercise option of fixation of pay within one month from the date of issue of this order otherwise their pay will be fixed under the normal rules.

The correctness of the pay fixation done under the Assured Career Progression Scheme should be got verified by the audit party.
