PROVISIONAL ARREST

It is understood that:

- the NCB of the country where the wanted person is found should immediately inform the requesting NCB (quoting *reference* and *date*) and the General Secretariat;
- If that country considers red notices to be valid requests for provisional arrest, the fugitive should be provisionally arrested.

- the European Convention on Extradition
- the Arab Convention on Mutual Assistance in Legal Matters
- the Convention on Extradition concluded by the members of ECOWAS
